

Requirements to sit for Melillo Method TM Certification Exam

Professional Degree & License Requirements

None required

Educational Requirements

Applicant MUST have completed ALL of the Melillo Method ™ Modules

Personal Requirements

- If working with clients after certified, applicant must be willing to attest to, agree to and adhere to all professional and ethical codes of conduct as indicated in the professional code of ethics for their given profession
- Applicant must be willing to attest to, agree to and adhere to working under their local governmental guidelines in regards to offering services of any kind to the general public
 - This Certification does NOT grant the applicant a professional license to work
 - This Certification **ONLY** shows a mastery in the Melillo Method TM coursework



Requirements to sit for MR. ROBERT Melillo Method TM Certification Exam

Personal Requirements (Continued...)

- Must be willing to attest to, agree to, and adhere to all requirements set forth to maintain Certification status once granted:
 - Twenty four (24) hours of Continuing Education every three (3) years
 - Three (3) case studies submitted every three (3) years
 - Maintain membership status with IAFNR <u>yearly</u>

Application & Payment

- Must fill out the application in full
- Fee of \$300 USD
- Have the application in by the deadline posted (no exceptions)



Requirements to sit for IBFN-CND Fellowship Exam:

Professional Degree & License Requirements

- License must allow for the diagnosis and assessment of injury, disease and/or disorder
- Hold the license and be in practice for at least one (1) calendar year
- Be using the work for one (1) calendar year
- Have no restrictions or oversight on your license

Educational Requirements

- At least one hundred fifty (150) hours of post-graduate continuing education hours, emphasis on Functional Neurology focusing on Childhood Neurodevelopmental Disorders
- Must be recognized and go through an accredited university recognized by the US Department of Education or an International equivalent (www.ed.gov)
 - Proof of attendance or hours must FROM the university not the seminar company



Requirements to sit for IBFN-CND Fellowship Exam:

Personal Requirements

- Applicant must have a clear societal record
- Applicant must be willing to attest to, agree to and adhere to all professional and ethical codes of conduct as indicated in the professional code of ethics for the given profession
- Must be willing to attest to, agree to, and adhere to all requirements set forth to maintain Fellowship status once granted:
 - Fifteen (15) hours of Continuing Education <u>yearly</u>
 - One (1) Case Study submitted <u>yearly</u>
 - Maintain membership status with IAFNR <u>yearly</u>
 - Recertification fee of \$200 due <u>yearly</u>

Application & Payment

- Must fill out the application in full and upload required documents:
 - Copy of professional license
 - Proof of attendance FROM university for all hours of education
- Fee of \$800 USD
- Have the application in by the deadline posted (no exceptions)
